REGISTRANTS FOR SECOND RACE ONLY MUST PRE-REGISTER**

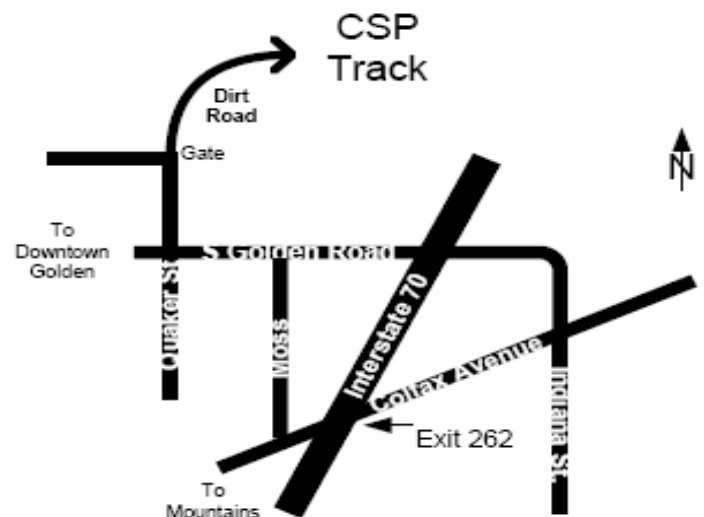
- Trophies \$15 per race. (\$20.00 day of event)

- Closed exhausts only
- Event will be governed per 2010 National Autocross Rules and Guidelines

Directions to the Colorado State Patrol Track, Golden, CO
 Take I-70 West to Exit 262, Colfax Avenue. Turn Right, West on Colfax. Make a right at Moss Street or the light and proceed North to S. Golden Rd. Left/West on S. Golden Rd. and make a right on Quaker. Proceed up the hill and through gate at "hard left." The road turns to dirt at this point. Take it slow and follow signs to the track.
